- During registration for World Conference, our fellow CMAA members/registrants were generous by choosing to add a donation to their registration donations increased by more than 45% over the prior registration year.
- Overview of the Annual Report: there was a 17% increase in the number of grants given in FY22 from the prior year, including 40 scholarships and 27 Chapter education grants. CF provided \$111,000 in outreach and industry grants. The dollar amount of scholarships and grant awards increased by 58.36% in FY22. Fundraising and event results also saw positive gains: contributions increased by 11.57% and a modest increase is budgeted for the coming year.
